

TERMS AND CONDITIONS

DAMAGES

The client will be held responsible for any damages belonging to Glampin' Around Michigan other than normal wear and tear. Any lost, stolen, broken, damaged, or destroyed equipment will require replacement, and will incur a fee equal to the full replacement value. Air mattresses are checked after each use. This does not guarantee potential deflation due to excessive weight, mishandling, or abuse. In the event of any items being excessively dirty or damaged, a cleaning or replacement fee will be required. Please refrain from wearing shoes inside the tents, spinning or dancing around the bell tent center pole, or use the bed trays for sitting or standing. Pets are not permitted in the tent area. Be mindful of food and beverages being served to prevent damages to any equipment. Refrain from coloring utensils, slime, fingernail polish, glue, or any colored beverages/food being used within equipment. Smoking is strictly prohibited in and around the tents. Firepits and BBQs are to be kept well away from the bell tent, as this creates a fire hazard. Bell tents may have minimal damage to the surrounding grass. This is due to lack of sunlight, leaving the grass yellowed, flattened and dry. This will fade following the reabsorption of sunlight and water.

LIABILITIES TO THIRD PARTIES

The client agrees that Glampin' Around Michigan (including its owners, agents, employees, successors, and assigns) assumes no responsibility or liability for accidents, injuries, death, or damage to the property that may occur with any of our products while in your possession. The client assumes all liability for and agrees to defend, indemnify, hold harmless, and protect Glampin' Around Michigan from and against any and all liability. Glampin' Around Michigan is not responsible for allergic reactions or other medical reactions stemming from the rental equipment, menu, fabrics, or any activity taking place before, during, and/or after the party. It is the responsibility of the client to take care and always supervise children with sleepover equipment.

LOCATION RESPONSIBILITY

Glampin' Around Michigan is willing to conduct your event at any location of your choice. Any venue fees will be your responsibility. If we are refused access to event space, no refund will be given and your party is subject to cancelation. You must inform your venue of Glampin' Around Michigan as a third-party vendor prior to your booking. Prior to your event, we will set a time for set up and tear down. It can take anywhere from 1.5 hours to 3 hours to set up and 45 minutes to 1 hour to break everything down. It depends on the size of event. We do not require the client to be present for outdoor set-ups or tear-downs. For the indoor set-ups, it is required for someone over the age of 18 to be present. If someone is not available or is more than one hour tardy for set up and tear down, your deposit will be withheld. The client is responsible for clearing the space for any equipment prior to our arrival. Glampin' Around Michigan does not move any furniture or belongings. If we arrive and space is not cleared, we will not set up and the party is subject to cancelation. Once the furniture is moved, please sweep/vacuum the area. We recommend a reasonable amount of space to ensure a comfortable experience for you and your guests. The Backyard Glampin' Bell Tent requires a 22' x 22' flat area for staking. The Indoor Tiny Tents are each 44" W x 76"L. Junior air mattresses are available upon request for an additional fee. The 20' Outdoor Movie Experience requires a 23' x 23' area. The Low-Profile Picnic Table requires a 5' x 8' area for one table and 10' x 16' for two tables. Please take into consideration the area around the bell tent including pathways, decks, and overhanging trees, septic systems, and power lines (for height). In addition, please have the area cleared of any debris or animal feces prior to our arrival. Also, please do not forget to turn off any outdoor sprinklers during your rental period. The stakes that are used for securing the tent & movie screen are approximately 12" long. Glampin' Around Michigan cannot guarantee that a pipe will not be hit and will not be responsible for the cost of any damages or repair. Location and demarcation of sprinkler lines and underground utilities are the responsibility of the owner of the home or venue. If the client knows the location of these lines, marking them would be advised. Glampin' Around Michigan will not refund any full payments in the event that adequate space is not available.

INCLEMENT WEATHER

In the event that inclement weather is forecasted and safety could be compromised, Glampin' Around Michigan may have to postpone your event. If this may occur, we will offer you the next best date.

PAYMENT

Once Glampin' Around Michigan receives the booking request form, along with a signature agreeing to the Terms and Conditions, the client will receive an initial invoice for \$150 (\$100 booking fee and \$50 damage deposit). Once Glampin' Around Michigan receives the payment, the event date will be secured. Seven days prior to the event date, Glampin' Around Michigan will confirm the details and the client will receive the final invoice for the remaining balance that is to be paid that same day. If Glampin' Around Michigan does not receive the final payment, the event may be subject to cancelation. The \$50 damage deposit will be fully refunded 24-72 hours after pick-up as long as everything is in good condition. The deposit will be refunded the same way it was sent by the client. If any items are damaged, stained, or missing, the deposit will not be refunded, and the client may be charged an additional fee. Payment methods accepted are Venmo (preferred), Zelle, PayPal, cash, check, or credit card (a 3.5% processing fee will incur). ** If a party exceeds \$2,000, the client will receive an initial invoice for \$550 (\$500 booking fee and \$50 damage deposit).

CANCELATION AND REFUND

If the client requests to change the date of their hire booking, a minimum of 10-day notice must be given. If an event is canceled for any reason, Glampin' Around Michigan will be happy to offer the next available date that works for you within one year's time. The client's request can then be granted only if the preferred date is available. In the event of an act of God, pandemic, or other catastrophic event, we will offer you the ability to reschedule your event within one year's time. If the client decides to cancel and not reschedule, their deposit will be forfeited. Glampin' Around Michigan reserves the right to cancel any event due to unforeseen circumstances. We will always try to give as much notice as possible. In such instances, we will refund the client any money paid or give you the opportunity to reschedule. If the client ordered any add-ons through a third party, they must contact them for their policies. Glampin' Around Michigan will not be liable to pay any compensation to the client or any other person for loss, damage or expenditure arising directly or indirectly from the cancelation. We also reserve the right to terminate the reservation without notice if there is a breach of any contract or conditions.

PHOTOGRAPHY

Glampin' Around Michigan reserves the right to use photographs taken at the event in any promotional media. At no point will Glampin' Around Michigan disclose any identifying information in these images. If the client would like an image removed, please contact us immediately. OUTDOOR MOVIE

The Outdoor Movie will only work once the sun is down. Although Glampin' Around Michigan provides a FireStick and HDMI adaptors to allow the client to stream from popular apps, a DVD player is also provided just in case the WiFi service is not strong enough for streaming capabilities. Glampin' Around Michigan encourages the client to have a DVD as a backup just in case streaming is not working.

OTHER

Delivery, assembly, styling, collection, and general laundering are included in the hire cost. There is a mileage fee of \$2.50/mile from Lawrence, MI, to the party location. Each party is unique and may vary a little from pictures on the website. Any changes considered to be major will be communicated to the client. Sleeping pillows are not provided for guests due to hygiene reasons. The client is responsible to communicate with their guests to bring their own pillow. The client may request a second night rental. The Backyard Glampin' Bell Tent will still be the standard price for a second night. However, the Outdoor Movie and Low-Profile Picnic Table will be free any additional nights. Each Indoor Tiny Tent will be \$25 per tent on the second night.
